BOARD MEETING MINUTES OCTOBER 17, 2019

I. CALL TO ORDER AND ROLL CALL

The October 17, 2019 Board Meeting was called to order at 5:00 p.m. by President, Mr. David Stuck. Roll Call was taken. All Board Members were present.

III. PUBLIC COMMENT

James Meade, on behalf of the Self-Advocates group reported the following:

IV. APPROVAL OF SEPTEMBER 19, 2019 MEETING MINUTES

A. Ethics Committee: The Ethics Committee did not meet.

B. Finance Committee:

1. Finance Committee Report

Rachel Malone reported the September Finance report was reviewed by the Finance Committee in detail. Rachel shared the following highlights:

- Additional revenue for HMG incentives was received.
- Journal entry corrections were made in conjunction with purchase order corrections at the Auditor's office. The Auditor's office mistakenly used a purchase order assigned to the Board and the expenditures charged against the PO have been corrected.
- Health Insurance for the facilities department is slightly high due to the retirement of a spouse and the addition to our plan.
- Health Insurance increase of 1% is expected going from United HealthCare to Anthem. Savings expected to be \$60,000.
- A new vehicle was purchased replacing an older one.
- Vendors used in and out of Erie County were reviewed.

2. Medicaid Waiver Match

Resolution #: 10-07-2019

Mr. David Stuck made a motion to approve the appropriation of an additional \$500,000 of CY 2019 funds to pay the non-federal share of the services required by section 5126.0511 of the Ohio Revised Code for Medicaid expenditures to assure the services will be available in a manner that conforms to all applicable state and federal laws. It is fully understood the payment of the non-federal share represents an ongoing financial commitment of the Erie County Board of DD.

 - Individual & Family Support Specialist (vacated position of Lesley Swope)

 – this position has been reposted.
 - SSA Manager (vacated position of Felicia Zendejas)

 – This position has been filled. Erin McDougall has accepted the Manager position and will begin in her new role in January of 2020.
 - SSA Assistant- Debbie Crosby has resigned from the SSA Assistant position effective December 31, 2019. This position will be reviewed and posted.
 - SSA (vacated positions of Kristen Barone, Christa Eastman and newly hired Manager)- We have three open SSA positions. Interviews are underway.
 - Part-Time Transportation Driver (2 positions) Jerry Clifton has been hired to fill one open position. We are reposting to fill the second open position.
 - Developmental Specialist- We are adding a full-time Developmental Specialist position, due to increased referrals and number of children served.
- Health Insurance: We have completed the process for our Health insurance renewal. Our new carrier will be Anthem Blue Cross Blue Shield with a 1% increase over last year's costs.
- OACB Federal Fly-In: Carrie had the opportunity to travel to Washington DC on 9/25-9/26/19. She met with the offices of Representatives, Jim Jordan and Marcy Kaptur discussing the issues challenging person's living and working in their communities and the pro's and con's of block granting Medicaid dollars to states. Carrie will be following up with their offices periodically to build an ongoing relationship with these legislators.
- Cannabis Law Training: Several management team members and Carrie participated in a Cannabis Law webinar training on 10/2/19 provided by the Erie County Chamber of Commerce. We will be looking at offering a training to all staff in the future.
- Building Bridges Awards Banquet: The 2019 ECBDD Building Bridges Awards Banquet was held on Thursday, October 10th, 2019 at Mesenburg's in Huron. A special thank you to Board Members who were able to attend. We had approximately 160 guests in attendance, including Senator Theresa Gavarone. The award winners for this year were:

- OACB Winter Conference: the OACB Winter Conference will be held December 4th, 5th and 6th, 2019 in Columbus. We are awaiting session information from OACB and will forward this to Board Members once we receive.
- Santa Workshop: The Erie Bd. Of DD Santa's Workshop will held on December 7th from 9:00am to 12:00 noon, at the Erie Bd. Of DD. Additional information will be provided to Board Members.
- OACB Information Technology Improvement Initiatives Report:
 - A "proof of concept" project is currently underway to allow county boards to update address information within their own systems and have those systems communicate the changes directly with DODD's databases. Currently, it takes county board 13 steps to change an address for someone in the state's databases. Moving forward it will be 2 steps (November 2019).
 - DODD is also automating updates for the new waiver match rates, which will save county board staff significant time moving forward and allow them to focus on providing an improved level of customer experience.
 - Ball v. DeWine Lawsuit Updates:
 - Lori Stanfa reported a tentative settlement agreement has been reached between the State of Ohio, OACB, and the group of plaintiffs primarily represented by Disability Rights Ohio.
 - As part of the tentative agreement, DODD will expand its existing options counseling and pre-admissions counseling programs, allocate 700 statefunded individual option waivers for people who choose a waiver, and increase support for affordable housing and integrated employment and day services.
 - A separate settlement agreement has also been reached between the State of Ohio, OACB, and a group of guardian/parent intervenors that promises to increase family notification about residential service options in Intermediate Care Facilities (ICFs).

X. EXECUTIVE SESSION
